

Competition rules Body warmer promotion

1: Organiser

This competition is organised by Novatech International, with registered office at Industrielaan 5b, 2250 Olen, Belgium (hereinafter referred to as: 'Organiser').

2: Promotion period and participants

This competition runs from 3 November 2025 to 1 December 2025.

Participation in this competition is open to any person aged 18 or over who is resident in Belgium, Luxembourg or the Netherlands.

Employees of Novatech International, its advertising agencies and any other person who has contributed to the creation of this competition are excluded from participating in this competition.

3: Participation

To participate validly in the competition, participants must fill in the required information (participating point of sale, surname, first name, email, telephone number, etc.), upload the proof of purchase and specify the desired clothing size via the web page developed for this purpose. Any incomplete entries will be considered void. Each participant may submit the required information only once.

The participating Tec7 points of sale can be found in the selection list.

Participants must submit the above information via the website, accessible at www.tec7.com/bodywarmer.

The Organiser reserves the right to reject fraudulent entries or limit them to a single valid entry, without having to justify this decision.

4: Prizes & winners

The prize pool contains the following prize:

A total of 500 body warmers are available, divided across the different sizes.

The Organiser reserves the right, if the desired size is no longer available, to send a different size or to declare the participation invalid if all sizes are exhausted.

After verification and approval of the entry (including proof of purchase), the Organiser will send the body warmer by post to the address provided by the participant, while stocks last.

5. Notification and receipt of the prize

Winners are deemed to have received the notification within 30 days of the notification being sent by email. If this does not happen, it will be assumed that the winners cannot be reached and their prize will be added to the prizes for the next competition.

The winner may not contest the prize they have won, nor request an adjustment or replacement for any reason whatsoever. Prizes are also personal and non-transferable. However, if necessary, the organiser reserves the right to award a prize of equal value to the prize provided.

Only one prize per address, per person, per IP address will be awarded. Any attempt at fraud will be punished by immediate exclusion of the participant.
